24-HOUR HOTLINE: STAFFED BY TRAINED VOLUNTEER COUNSELORS WHO SPEAK 10 LANGUAGES INCLUDING SPANISH, FRENCH, KOREAN, AND HINDI. TO ENSURE QUALITY ACCESS FOR ALL, BARCC ALSO USES A TELEPHONE TRANSLATION SERVICE, AND THE MASSACHUSETTS RELAY SERVICE FOR DEAF OR HARD OF HEARING CALLERS. IN FY15 85 VOLUNTEERS ANSWERED 5, 086 CALLS.

LEGAL ADVOCACY: COMPREHENSIVE LEGAL SUPPORT THAT HELPS SURVIVORS AND THEIR FAMILIES WITH CRIMINAL AND CIVIL LEGAL ISSUES STEMMING FROM AN ASSAULT. IN FY15 BARCC'S LEGAL ADVOCACY PROGRAM SERVED 263 CLIENTS.

CASE MANAGEMENT: ASSISTANCE TO SURVIVORS WITH THE COMPLEX ISSUES THAT FREQUENTLY ARISE IN THE AFTERMATH OF SEXUAL VIOLENCE, INCLUDING ISSUES OF HOUSING, MEDICAL FOLLOW-UP, INSURANCE, EDUCATION, EMPLOYMENT, AND ECONOMIC STABILITY. IN FY15 BARCC PROVIDED CASE MANAGEMENT SERVICES TO 175 CLIENTS.

FORENSIC INFORMATION SERVICES: A STATEWIDE SERVICE THAT PROVIDES FORENSIC INFORMATION AND SUPPORT TO SURVIVORS. SERVICES PROVIDED INCLUDE A WEBSITE THAT INFORMS SURVIVORS ABOUT FORENSIC RELATED ISSUES, WWW.SURVIVERAPE.ORG, AND TWO INFORMATION LINES THAT ASSIST SURVIVORS WITH RESULTS FROM THEIR TOXICOLOGY KIT AND EXTENDING THE STORAGE OF THEIR EVIDENCE COLLECTION KIT. THESE SERVICES CAN HELP SURVIVORS WHO ARE DECIDING WHETHER TO FILE A POLICE REPORT.
